


# Instructions for the CLEMM 100W CORE POWER ADAPTER

Model: CWC-100-A3C-CGR



#### PACKAGE CONTENTS

- USB power adapter 1 pc.

Purpose: Device for charging batteries of portable devices from an AC power outlet.

#### Safety instructions

- The device is intended for use in residential, commercial, and industrial areas free from harmful and hazardous industrial factors.
- 2. Use the device only with IT equipment.
- 3. The maximum air temperature during device operation should not exceed 95°F.
- 4. Keep the device away from open flames, like candles.
- 5. Disconnect the device from the power outlet by unplugging the AC plug from the socket or disconnecting the power cable from the device.
- 6. The socket should be installed near the equipment and be easily accessible.
- 7. Do not use the device for industrial, medical, or manufacturing purposes.
- 8. If you want to clean the device, use only a dry cloth or brush.
- 9. Do not allow moisture to enter the device.
- 10. Do not subject the device to mechanical stress that could damage it.
- 11. Do not use the device if it is visibly damaged.
- 12. Do not use the device if it is known to be faulty.
- 13. If the cable or plug is damaged, the device must be disposed of.
- 14. Service center specialists do not repair the power supply if it is damaged or any component is defective (the device may be disposed of).

For fast and safe charging, use a CLEMM cable, your device's original cable, or another cable certified by the manufacturer.

### Using the device

- 1. Connect the charger to a power outlet
- 2. Connect the smartphone USB charging cable to the USB port of the power adapter.


USB-C1/C2 Max 100 W

#### **Disposal**
